Liberty for America PAC Treasurer Carol McMahon has been elected to town office in her home town of Beacon Falls, CT. She did so with the active support of the local Democratic Party, which knew it would rather deal with a sensible Libertarian than a Republican. In the end, the Republican Party was so disorganized that it failed to field candidates against her.

Liberty for Maine

Liberty for Maine State Chair James Oaksun writes us on Liberty for Maine activities:

1. Had an op-ed on health care reform published in Maine's largest daily paper, the Portland Press Herald. Well received, more than 300 online comments. 2. Issued news release in opposition to Ballot Question 1. Various religious and right-wing groups are attempting a "people's veto" of Maine's marriage equality law. A "Yes" vote will veto the law; a "No" vote affirms the law as it stands, as passed by the legislature and signed by the Governor. The release is at <http://www.pr.com/press-release/177188> . [Alas, Maine Ballot Question 1 passed.]
3. Op-ed piece regarding usage of Willard Beach in South Portland, Maine. Suggested a free market/public choice solution inspired by work of the recent Nobel laureate Elinor Ostrom.
4. Produced six Internet videos (various locations) in opposition to the "People's Veto" ballot question. One of them, titled "Fred and the Bishop", proved reasonably popular. Links to the videos are at:

5. Issued "Sermon on the Mount", with a special introduction that I wrote. Some explanation: various conser-

vative Christian groups (the same forces trying to overturn marriage equality in Maine) are this fall distributing 50,000 copies of Darwin's Origin of Species on college and university campuses. This is a "special edition" which includes an introduction lambasting Darwin and scientific progress generally. In response I put together an e-book of Sermon on the Mount, with an introduction assessing how the Sermon's words can be applied to treatment of gay men and lesbians in civil society. Since Bishop Malone -- the Catholic bishop of Portland -- has been the leading figure in trying to overturn marriage equality, I delivered the first copy to him. Joe Kennedy for Senate

Massachusetts Libertarian Joe Kennedy is going through the huge effort needed to get on the ballot in Massachusetts, to give the people of Massachusetts a libertarian voice in the January 19 special election to replace Senator Edward Kennedy. To get on the ballot, Joe needs 10,000 signatures validated by town clerks and city halls, plus a big safety margin in case of challenges. Joe has the endorsement of the Libertarian Association of Massachusetts, which gave him \$800 from their Federal APC, did a fundraising mailing for him, and distributed copies of his nominating petition papers with their state newsletter.

Thanks to the hard work and generous financial support of libertarians across the country, and the diligent and generous efforts of libertarian petitioners, Joe Kennedy now has more than 17,000 raw signatures, which should be enough to qualify him for the ballot.

The Kennedy campaign JoeKennedyForSenate.com has reached the signature distribution stage, getting the nominating papers to individual town and City Halls to be validated. His chances of passing the rigorous Massachusetts ballot access laws and being on the general election ballot are currently pretty good.

The Liberty for America PAC supported Joe Kennedy, though not with your dues money. Yes, Liberty for America has a Federal PAC. Its Treasurer is Carol McMahon of Connecticut. Our PAC accepts money to support libertarian candidates. Our PAC also receives your dues money, which it uses to advance our purposes other than supporting candidates.

Our candidate-supporting effort struck a blow for liberty! While the LNC dithered, the Liberty for America PAC sent \$300 to support the Federal campaign of Joe Kennedy.

Joe is a member of the national party, a member of the Libertarian Association of Massachusetts, and was just elected to the LAMA State Committee. He needed an absolute minimum 15,000 raw signatures to get on the ballot. We paid for 300 of them.

To assist our candidate-support effort, which can support libertarian Federal candidates across America, send your check payable "Liberty for America" to Liberty for America, c/o George Phillies, 48 Hancock Hill Drive, Worcester MA 01609, and mention you want it used for candi-

date support. Our PAC will not support Republicans, Democrats, Greens, or Constitutionalists—they have their own parties. We will support libertarians, whether they run as Libertarians, Independents, or (some states have odd ballot access laws) under some similar ballot line name.

The Draft Rob Power for LNC National Secretary campaign now has a facebook page "Draft Rob Power for LNC Secretary". Rob has made clear that he will run if there is an honest draft with support. To support Rob, please join the Draft Rob facebook page.

Long-time Libertarian activist Carolyn Marbry writes of Rob Power "Rob Power, national chair of Outright Libertarians and chair of LP San Francisco, would make a fantastic secretary for the LNC. I've never seen anyone with the kind of energy Rob has devoted to activism. He's exactly what the LNC needs."

Former LPTN Vice Chair, candidate for Governor, and Libertarian activist Charles Wilhoit has also endorsed Power, writing "I am also announcing my support for Rob Power for LNC Secretary. Rob says he spent the first 24 years of his life in Tennessee. Here are the details:

Born and raised in Nashville, Rob Power attended the University of Tennessee, where he was President of the Lambda Student Union and Chair of the Gay and Straight Political network, which sought to add sexual orientation and gender identity to the University's official nondiscrimination policy (eventually accomplished in 2007, seven years after Rob finished his MS/MBA at UT).

While working as the Director of Engineering for a dot-com in Oakland, California, Rob became Vice-Chair of the Libertarian Party of San Francisco and founded our organization's first West Coast chapter, Outright Libertarians of the San Francisco Bay Area, and served as the chapter's first Chair. He was elected Chair of Outright Libertarians USA at the 2004 annual meeting, concurrent with the Libertarian Party Presidential Nominating Convention in Atlanta.

While living in Cambridge, Massachusetts, he legally married his husband in 2007, and moved back to San Francisco later the same year. He is currently in his second term as Chairperson of the Libertarian Party of San Francisco."

Your Monthly Political Step

This month we discuss a political step that you will hopefully never need to take. The step is called "damage control". Damage Control arises with considerable frequency in political life. Consider (details changed to protect the not entirely innocent): Your local mayor is found to be paying child support to Miss Your Town Milk for Health 1995. Your Attorney General was in a car crash in which he was going 90+ miles an hour while not wearing a seat belt. Your Congressman rammed the Capitol Building with his car, saying he had to make a critical vote — at 1:30 in the morning. Your Senator's staffers include people who cannot type, take dictation or answer the phone. And, of course, your campaign committee included a young man who knew that *Mission: Impossible* reflected sensible ways that actually work in real politics, and who had the cash to prove he was right.

No matter your challenge, damage control is a well-defined issue. There are a few basic principles, notably: The issue will not go away. Whatever you were trying to cover up, it will get out. In particular, it will get out slowly and painfully, keeping the issue in front of the public. Conspiracies of silence are largely ways to build up friends in the press — by leaking them the secret. (If you are lucky, it will be the real secret, not something bloated to make the leaker look good.) The public dislikes damage, but it dislikes prevaricators more.

What is the solution? 1) Get the real facts. Be sure you have them right. 2) Don't try to hide from the truth. The truth will seek you out, and it is smarter than you are. 3) Once you are sure you have the truth, put it out in front of the public, not flamboyantly, but out. 4) If there are any parts that can be blamed on you, be sure that you admit your errors before you can be nailed on them. 5) 'Taking responsibility' for misdeeds requires correction, which may involve people having foreshortened political careers.

The Waco Holocaust was a hideous disaster that killed scores of people. If the Attorney General had actually taken responsibility, namely firing the responsible people down the organizational chart, and then resigning, the politics of extreme paranoia would have received far less of a boost. Even better, if she had shut down the farce of a siege of the Davidian Church — this is not how we do things in America — she would have gained positive credit with civil libertarians. She didn't. That's how we got from Waco to Oklahoma City: one evil deed followed from another.

The most important rule on damage control: Be honest, open, and forthright as soon as possible. If you don't have an answer to a question, say so, and get that answer soon.

Republican Party Continues Its March to Death

There is some really good news out there politically. America has a two-party electoral system, meaning that third parties such as ours have problems with winning elections. Fortunately, the national Republican Party is preparing to get out of our way by committing political suicide and transforming itself into a regional party of eccentrics, namely the Party of Southern Sectarian Christian White Male Conservatives. Liberal Democrats have proposed for them a new political mascot: GOPY the Gopasaurus, a red-white-and-blue dinosaur speeding to extinction.

In a certain sense, we are seeing the divergence of political opinions between different parts of the country that we have seen before. This time, the differences with a few exceptions are less likely to lead to violence than they were in 1840 or 1850, but the divergences are still there. One radical difference from 1850, from what we know of that distant time, is that in 2009 a major dividing line is generational more than geographical. The people who support Republican social-conservative thinking against abortion and gay marriage, and for the war on drugs, are in substantial part an older generation that is preparing to depart this earth without being replaced, at least politically.

The 2009 general election shows the Republican Party taking additional steps toward the graveyard. The Republican candidate for Governor of New Jersey won. He demonstrated that if you are an incumbent Governor in difficult economic times, a man whose background is associated with the people blamed for the 2008 -2009 Great Recession, if your contribution to public concern about corruption in office was a car accident in which your vehicle was traveling over 90 miles an hour and you were not wearing the legally-mandated seat belt, then you should not be surprised when the voters conclude that almost anyone might be an improvement. The Republican also ran as a moderate, facing a governor widely seen as mediocre.

The Republican candidate for Governor of Virginia also won. His previously-expressed personal stands on personal liberty issues, against abortion, against 'fornicators', against working women, against homosexuals...the list

goes on a bit...made him a shining champion of the southern white male conservative Republicans, but by the same token reminded voters elsewhere in the country as to why they do not support the Republican Party and do not want social conservative Republicans representing them in Congress. Having a weak opponent did not hurt McDonnell either.

The peculiar election in New York-23, featuring a three way race between candidates of the Democratic, Republican, and Conservative parties shows again the difficulties the Republicans face. The legitimate Republican candidate received Republican money, but had so few prominent Republicans as supporters that she finally withdrew from the race. Indeed, many Republicans appeared in her state to aid her Conservative Party opponent. In the polls she did so badly that she finally withdrew from the race. As a result, northeast of Pennsylvania the Republicans are down to two Congressmen.

And now we come to the point where Republican social conservatives do not understand what happened to them or what it means. The Republican candidate, having withdrawn, could have said nothing. She could also have spoken up to endorse one of her opponents, and that is what she did. Of course, she was the Republican. Her opponents were candidates of two enemy political parties, the Democrats and the Conservatives. Was there a dime's worth of difference between them? To her, indeed there was. She endorsed the Democrat, who went on to win the election. The message was very clear. To a centrist Republican, the social reactionary Conservative was simply not acceptable. Social Conservative extremism is unsaleable in most of the United States other than the deep south and parts of the Rocky Mountains.

Conservatives are drawing a completely different conclusion from the same election, namely that Republicans should run far-right-wing conservatives. Cheer them on! They're nailing shut their coffin...from the inside. Evidence that this approach will elect Republicans outside the deep south are, fortunately, substantially lacking. The Republicans are already placed to run way way way right on the National level, where at least four of their candidates, Huckabee, Palin, Pawlenty, and Paul, have made clear they do not believe in evolution. Indeed, the first three have made clear that they believe the world is not even ten thousand years old, while the fourth sensibly only talks of his opinions on these questions in front of entirely friendly audiences. A fifth candidate, Romney, whose political positions this week are apparently quite conservative, runs into a different religious difficulty, namely that his faith is completely unacceptable to many backbone Republicans. (Of course, JFK beat that wall.)

Libertarian Centrism

How are we to tell Libertarian Centrism apart from radical anarchism, Republican-lite conservatism, conspiracy theorism, and inner-office internal politics? I offer a few thoughts.

Libertarian centrism is about doing real politics. Libertarian centrists do not agree about everything. That's not necessary.

Here are a few litmus questions. Litmus paper is not completely reliable. It's an indicator, not an ironclad measure of reality. An issue can be a good litmus test without it representing an important issue. Equally, some important issues are not litmus tests.

What do most Libertarian centrists believe?

Libertarian Centrists support social liberty:

We are 100% pro-choice, because government has no legitimate business running women's lives for them.

All Americans are entitled to equality in marriage, adoption, divorce, and access to military service.

Slavery was the American Holocaust. Confederate apologists are rightly grouped with Holocaust deniers, and are shunned by all decent people.

Thomas Jefferson correctly wrote: "That to secure these rights, Governments are instituted among Men". It is only through government, limited government, that men and women will stay free.

The so-called 'States Rights' doctrine, claiming that states may keep African-Americans from voting and women from having abortions, and gays from marrying, is un-American. Politicians who say 'leave it up to the states' are an opposite of libertarian.

While there have been conspiracies, the incoherent mutterings of conspiracy theorists, including truthers, birthers, tenters, and 14th/16th amendment deniers offer nothing to the Libertarian political movement. They should be politely ignored.

Conservatism, real conservatism as it actually exists in the modern Republican Party, is one of the two natural foes of libertarianism, the other natural foe being modern liberalism.

What does Libertarian Centrism offer America? What is

the clear, positive, uplifting message we send about the American future? How will Libertarian centrism advance the Libertarian political movement?

Libertarian centralism stands for peace. That's the opposite of Democratic-Republican perpetual war. Corporate defense welfare should end. We should end the Bush-Obama war on Iraq and the Obama-Bush war to impose the dictator Karzai on the people of Afghanistan.

Libertarian centralism stands for opportunity. Massive over-regulation leaves people poor and dependent. Over-regulation selectively targets the poor and the dark of skin, the people who lack attorneys and bureaucratic cronies to guide them. The opposite of opportunity is corporate welfare, including defense welfare, agricultural welfare, and welfare for the bankster friends of the Secretary of the Treasury.

Libertarian centralism stands for freedom. We are not afraid of the future. We will end the conservative security state, which is the chief menace to our freedoms and to our country's future.

Libertarian centralism stands for the modern world. That's the opposite of the anti-reality yahoos who deny global warming, cower in fear of recombinant DNA, deny that air and water pollution can kill you, flee in terror of nuclear energy, and deny evolution.

Libertarian centralism is the path to the Libertarian Future.

How will we reach the Libertarian future?

We need a national Libertarian Party that does real politics. That group may or may not finally be LNC, Inc.

What should a good national party organization do?

Here are some thoughts one what Libertarian centrists should propose that a National Party should do. There are some parts that have not yet been laid out, parts like a solid time line and a budget. These are issues and themes on which a centrist renaissance caucus might run a slate of candidates.

Revive/create state organizations in all 50 states, D.C., and Puerto Rico. We may or may not have 50-state ballot access, but we do need to have 50-state and other places activism. In particular, Puerto Rico is the home of nearly four million people who can come to the 50 states and soon be voters. They should be exposed to our Libertar-

ian ideas before they get here, by forming a Libertarian Party affiliate in Puerto Rico. Other proposals:

- 1) Mobilize the Libertarians! -- a national party much more heavily focused on volunteer activities.
- 2) Use the budget to go for content-based finances -- the Massachusetts Plan.
- 3) The newsletter should be monthly and focused on activism.
- 4) The LNC should concentrate on substantive activity, not parliamentary procedure and fiddling with the policy manual.
- 5) LfA already delivers two monthly magazines, Libertarian Strategy Monthly and Liberty For America. We have a campaign support disk. We could have downloadable trifolds. What is our competition doing?
- 6) We should sell themes of libertarian centralism:
 - equality before the law for all Americans
 - we're pro-choice.
 - end selective service...end defense welfare
 - true gender equality
 - government spying on all Americans via illegal wire-taps is evil and criminal
 - end the wars
 - restore fiscal prudence -- Uncle Sam is broke
- 7) Robert's Rules of Order should be a comfortable fleece pullover, not a straitjacket. Roberts' Rules are supposed to assure that the minority may be heard and the majority may act. We should cheer party members who individually pursue quaint hobbies, like quilting, jousting, or becoming certified parliamentarians, but quaint hobbies do not make anyone a party leader. When a body spends most of its time arguing about parliamentary procedure, something is very wrong.

Where Your Money Went

Libertarian National Committee — Filing Covering September 2009

Here we report on how the Libertarian National Committee spent your donations in September. These numbers are all from the LNC FEC reports. Reasonable care has been taken to assure that all numbers have been recorded in the correct columns and aggregated correctly, but there is always some possibility of error. Readers who want to check for error should compare against the actual reports

available at FEC.GOV.

For September 2009, the LNC began the month with \$14538, had income of \$97344, spent \$83370, and ended the month with \$28512 cash on hand. Reported debts were \$13497. For the year, the income to date was \$822,141, implying that for the year the total income will be around \$1.08 million.

The biggest story in the report is perhaps the smallest number, the money spent in support of Federal candidates. In the words of the LNC's FEC report: "The Committee wishes to disclose the following: 1) No expenditures designated on Schedule B supporting Line 21b were made on behalf of any specifically identified federal candidate(s)." That is, having gone through more than \$800,000 this year, the LNC isn't up to supporting its own party's candidates. (Liberty for America did.)

Absent from that spending total is rent. \$10,929 was paid to Bentley Forbes Watergate on the last day of the prior month.

Almost half of disbursements went to the staff. This number includes not only the actual net pay, but social security, medicare, withholding to state and Federal destinations, unemployment taxes, the 401K plan, health insurance, and payroll processing, for a total just over \$39,400, a number that does not include \$1140 paid to Arthur DiBianca of Texas for administrative services. An additional \$816 went to Broadway Premium Funding for D&O insurance.

In addition, there were payments to outside experts, totaling \$11,990, such as \$3000 for accounting services to the CPA, \$1250 for FEC filing, \$2000 to Andrew Davis for LP News writing, and \$5540 for legal expenses including the New Hampshire Ballot Access Suit. \$1250 went for a media clipping service.

Money costs money to raise. Credit card processing and bank fees were just under \$2500. Traditional office expenses for postage and copier charges came to \$2000. Office supplies were \$2125.

Electronic services came to more than \$8000. The largest payment, for \$3000, went to Lyris Tech for email marketing, followed by \$2300 to Terra Eclipse for the web site, with \$649 to Rackspace for web hosting, \$547 to ThePlanet.com for email service hosting, nearly \$1280 to PAETEC, Telecomputem and GoToMyPC for phone and data services and PC remote access, and \$215 to Accurint for address and phone verification.

In the end, we have a large operation, almost \$100,000 a month, that generates a surplus of a few thousand dollars a month for legal services and sends out press releases regularly. It is no longer up to publishing a monthly newsletter. \$1.1 million a year would appear to be larger than the budget of all the other libertarian party groups in the United States, put together, perhaps by a fair factor. And what are we getting for it?

How Tennessee Handles Volunteer and Contact Information:

An idea for your state to follow. The responsible party member forwards the information as described below, or contacts the people himself, and on a regular basis tells the state committee what is happening:

This is a report on action taken to date with information received from LP Headquarters on prospective members who have volunteered or requested information about the Libertarian Party.

1. In Counties with a County Chair (ALL CAPS) the information is forwarded directly to the County Chair to take the follow-up action.
2. In Counties where there is no County Chair a volunteer personally takes the follow-up action, either by e-mail, USPS letter or telephone.

Aaron Starr Named Second Alternate to Platform Committee

By a 7-5 vote with 5 members not voting, the LNC has appointed Aaron Starr to be the second alternate to the platform committee. The party's right wing continues to stack its deck. The vote was:

In favor: Bob Sullentrup, Aaron Starr, Alicia Mattson, Scott Lieberman, Rebecca Sink-Burris, Stewart Flood, Dan Karlan

Opposed: Lee Wrights, Mary Ruwart, Tony Ryan, Julie Fox, Rachel Hawkridge

Abstaining: Bill Redpath, Michael Jingoian, Michael Colley, Pat Dixon, James Lark

California Regional Representative Mark Hinkle chose not to vote, leaving the vote for his Region to Alternate Scott Lieberman. Lieberman as was known in advance voted in favor of the appointment.

LNC Mostly Ignores Kennedy Campaign

I would be delighted to report that the Libertarian National Committee is supporting a party member currently

in a Federal Election campaign, but that's only very slightly the case. Kennedy has repeatedly called and emailed the National Party offices, and informs me that he has had no response at all. He did, however, discover that a 4:30 in the afternoon call may reach only an answering machine, not even an intern. At most recent report, his letter to the entire LNC asking whether they would help him went unanswered.

I'm informed by several LNC members that the LNC was told by the Washington Headquarters that Kennedy is not a National party member, and therefore that he would not be supported. (I can assure you that Kennedy is a National Member). The National Party's Executive Director finally retracted this claim from his office. After considerable back and forth with the MA state Libertarian Association, the LNC did add a link from their web pages to Joe's campaign. You can't find Joe on the list of 2009 candidates, but if you dig deeply enough on the Massachusetts state pages you will find where Joe is mentioned.

The Libertarian Association of Massachusetts spent a substantial effort trying to explain Massachusetts ballot access laws to members of the National Committee. Kennedy is not running on the Libertarian line — not that Massachusetts ballots have lines. On the day the election was called, he was registered as "Unenrolled" (independent), so he could not legally run as a Libertarian Party candidate. Kennedy was allowed to choose a name for his line that is not Republican, Democratic, or Libertarian. He chose to use the designation "Liberty" as a representation of his views.

"Not registered Libertarian" was good news. If Kennedy had been registered 'Libertarian', the effort needed to put him on the ballot would more than doubled, and the whole campaign would have been called off as impossible.

Libertarian Party Membership Keeps Falling

The end-of-month membership totals for LNC, Inc., indicates that party membership fell from 13787 to 13618. A footnote asserts that the actual number of By-laws Defined Sustaining Members is actually 13,549. The 13,549 number is important because it is used to allocate delegates for the national convention; the number is preliminary because people whose postmarks show they mailed their renewals in October are to be counted in the total number of members, even if their renewal checks have not yet quite reached the National Committee. 636 members renewed, 285 new members joined, but 1089 members let their membership lapse, or so the report indicates.
